ESTABLISHMENT ORDER NO. 26/2014 DATED 01.08.2014

The following Senior Tax Assistants are hereby promoted to the grade of Inspector, Central Excise, Group 'B' non-gazetted on *ad-hoc* basis in the pay band of Rs.9300-34800 (+) grade pay of Rs.4600/- (plus usual allowances as admissible) from the date they actually takeover the charge:-

- 02. The above officers are promoted purely on *ad-hoc* basis against the Cost Recovery posts and such promotions do not confer any right of the individual concerned to claim regular promotion/seniority in the higher grade etc.
- 03. Shri Rajiv Balde & Shri Jayant Ghirnikar, Inspector promoted vide Estt. Order No. 18/2014 dated 13.07.2014, against Cost recovery basis, are hereby regularized.
- 04. The officers who have already been given the benefit of 1st / 2nd Financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
- 05. The above officers should join their new post latest by 10/08/2014. If they fail to join their duties by the said date, it will be treated as their refusal to accept promotion and accordingly, their promotion order will be cancelled without any further notice. Consequently, they will not be considered for promotion in terms of Para 3 of O.M.No.22034/3/81-Estt.(D) dated 01.10.81 for a period of one year or till the next vacancy arises, whichever event takes place later.
- 06. The above promotion is subject to the outcome of W.P.C.T.No. 261/2008 filed by Shri Samiran Roy & Ors. Vs. U.O.I. & Ors. before the Hon'ble Calcutta High Court, SLP registered as CC No.5272-5284/2008 in the case of UOI Vs. A.Karunanithi etc., OA No.960/2011 in the case of Sanjay Pathak Vs.UOI pending with CAT Jabalpur and OA No. 1063/2012 filed by Smt. Divya Patni Vs. UOI & Ors. Pending with CAT, Jabalpur.
- 07. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained.
- 08. The seniority position of above promoted officers in the seniority list of Inspector will be fixed as per DOP&T's O.M. No. 22011/7/86-Estt.(D) dated 03.07.1986.
