- 02. The officers who have already been given the benefit of 1st/2nd/3rd Financial upgradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
- 03. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained.

- 04. The seniority position of above promoted officers in the seniority list of Stenographer Grade-I will be fixed as per DOP&T's 0.M. No. 22011/1/2012-Estt.(D) dated 04.03.2014.
- 05. Consequent upon the promotion, all the above officers are retained in their present place of postings except officer at Sl.No.12 who is on deputation to DGCEI, ZU, Bhopal. The officer at Sl.No.12 should join on promotion in his parent Commissionerate by date mentioned in preceding para.
- 06. The above officers should join their new post latest by 04/04/2016. If they fail to join their duties by the said date, it will be treated as their refusal to accept promotion and accordingly, their promotion order will be cancelled without any further notice. Consequently, they will not be considered for promotion in terms of Para 3 of 0.M.No.22034/3/81-Estt.(D) dated 01.10.81 for a period of one year or till the next vacancy arises, whichever event takes place later.
- 07. The Principal Commissioner/Commissioner concerned shall ensure that if any of the officers whose name has figured in table above to this order is/are not cleared from vigilance angle, he/she should not be allowed to join on promotion.
- 08. The respective Commissioners are requested to submit a consolidated joining report of the above officers to this office by 08.04.2016.
- 09. This order is subject to the Board's decision on uniformity among Stenographers (Grade-I) across all Zones.
- 10. This issues with the approval of Chief Commissioner, Central Excise Bhopal Zone.
