ESTABLISHMENT ORDER NO. 25/2016 DATED 22.03.2016

Shri Abhay Puranik, Senior Tax Assistant, Customs, Central Excise & Service Tax, Nagpur (in the common cadre of Central Excise, Bhopal Cadre Control Zone) is hereby promoted notionally w.e.f. from 30.09.2014 to the grade of Inspector, Central Excise, Group 'B' non-gazetted in the pay band of Rs.9300-34800 (+) grade pay of Rs.4600/- (plus usual allowances as admissible).

- 02. If Shri Abhay Puranik, Sr.T.A. has already been given the benefit of 1st/2nd/3rd Financial up-gradation under ACP/MACP Scheme he will not be entitled for the pay fixation benefit.
- 03. The above officer should join his new post latest by 31/03/2016. If he fails to join his duties by the said date, it will be treated as his refusal to accept promotion and accordingly, his promotion order will be cancelled without any further notice. Consequently, he will not be considered for promotion in terms of Para 3 of 0.M.No.22034/3/81-Estt.(D) dated 01.10.81 for a period of one year or till the next vacancy arises, whichever event takes place later.
- 04. The above promotion is subject to the outcome of decisions pending in various judicial for a including decisions pending in OA No.960/2011 in the case of Sanjay Pathak Vs.UOI pending with CAT Jabalpur.
- 05. Under the provisions of FR 22(I)(a)(1), the promoted officer has to exercise his option for fixation of pay within one month of his promotion. He may further note that no request for condonation of delay in exercising the option shall be entertained.
- 06. The seniority position of above promoted officer in the seniority list of Inspector will be fixed as per DOP&T's 0.M. No. 22011/1/2012-Estt.(D) dated 04.03.2014.

07. Transfer and Posting:

Consequent upon the promotion of the above-mentioned officer, he is retained at Central Excise Nagpur Zone. The specific postings within the jurisdiction of the Zone will be made by the Chief Commissioner, Customs & Central Excise, Nagpur.

08. All the officers should ensure proper take over and hand over of charge. List of all urgent and time bound maters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officer should also make a note for the successor on issues of current importance,

urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-TRG(Trg-Ref) dated 26.09.2014

- 09. The Principal Commissioner, Customs & Central Excise, Nagpur is requested to submit joining report on promotion of Shri Abhay Puranik to this office by 04.04.2016.
